Earlier this month I attended the Area 15 quarterly assembly, in Fort Lauderdale. The area had no motions on the agenda that had anything to do with Corrections. At our corrections workshop about 2/3 of the 20 districts were represented. After listening to the reports form the other districts, I am feeling especially grateful for the awesome relationship District 20 AA has with the Collier County Sheriff's Dept.

At our Corrections business meeting on Monday we welcomed Officer Katina Bouza. Katina is our contact person at the CCSO, and she is leading a charge of changes that focus on inmates' positive behavior. She shared with us some of these changes. Really they don't affect us AAs carrying our message inside the jail. Katina was able to clear up any rumblings of negativity that members may have displayed – sharing the "big picture" with us and putting everything in a little better perspective. It was an incredibly positive, productive meeting!

Our Literature Chair, Tim S., purchased more literature for the inmates at Collier County Jail. At the end of December, the following books were delivered to the jail by Tim.

- 40 Daily Reflections
- 40 Big Books

The total for this order was \$674.

The Corrections Committee is completely self-supporting. We do not receive a "budget" from District. That said, the committee appreciates all group donations. 100% of all group donations are used to purchase AA literature for the inmates at the Collier County jail. Thank you to the Brown Bag, New Dawn, Living Sober, and Came to Believe.

Finally, we "officers" on the Corrections Committee are starting our second year of our two-year commitment. Therefore there is not a need for an election. However, our alternate chair had to step down from his position a few months ago. The Alternate Chair's main concern is the organization of our annual fund raising picnic in November. At our February 3rd Corrections Committee business meeting we will discuss the vacant alternate Chair position. As of now, I think that Tim S. is willing to take on the responsibility of the organizing of the picnic.
