1. District 20 Archives Report- <u>archives@district20aa.org</u> District 20 April 2014 Archives Report

I attended the quarterly in Tampa and had a wonderful time. The Archives committee is considering 3 motions to bring to the area in July.

Motion #1 is to request a new line item on the area budget for Archives. This would be to donate \$200.00 each year towards expenses for the annual Florida Archives Workshop.

Motion #2 is to vote on bringing in a new permanent position for an Area 15 Archivist.

Motion# 3 is for the Area to provide one night's lodging at the Annual Archives Workshop.

This is being discussed within the Archives committees in the areas and I will report back with further information in the future if they are approved. Some more information being considered on these motions is doing away with the money allotted for the Area 15 archives chair to attend the National Archives Workshop. I voted No to that

consideration because people in Archives stay around for years and don't rotate out like other committees for the reason of how much education is needed to be good at it. I have been to both The National Archives Workshop and the Florida Annual Workshop. The weekend at the national is the only place that actually teaches hands on preservation. So for the integrity of AA history I feel it is best to have well trained archivists.

We will continue meeting the first Thursday of the month at 9:30 am at the 24 hour club. Both Amy and Laurel have agreed to take the responsibility for the archives displays at Founders Day and Serenity by the Sea. I regret that my work schedule is non changeable and has me working through both. I am grateful for their willingness. They have both been with me from the beginning and know how to do things well. We continue to work with CCSO coordinating AA meetings inside the jail. The men's project recovery meetings are well attended, but the general population meetings only have 1-5 inmates in attendance. This is something that is not going to change. The women's meetings are quite large, but they include project recovery, a few general population inmates, the women in the "cell dog" program, AND the cell dogs. I have requested to attend a monthly CCSO supervisors' meeting to share with the corrections professionals about the value of AA and corrections professionals working together to give anyone with a desire to stop drinking an opportunity to attend an AA meeting. I have not been denied, but I've not yet received approval.

Tim S. is our new District Corrections Alternate Chair Person.

Tim attended the Area 15 Quarterly Assembly earlier this month – representing District 20 Corrections. Tim shared our struggles with the new issues we are having, and learned that we are not alone in our struggles. Other districts are having similar struggles.

This coming Monday is when our committee would have our regular business meeting, but we are NOT meeting. Our next Corrections Committee meeting will be Monday in June 5, 6pm, at the Intergroup meeting room.

Finally, the Corrections committee is grateful to the following groups for their generous donations. 100% of group donations is used solely for purchasing literature for the men and women inside the Collier County Jail.
