

I had the pleasure of attending the Area Quarterly April 11th-12th. I attended the Web Committee meeting on Saturday where the main focus of the meeting was on the launch of our brand new Area 15 website.

The Area 15 Web Chair announced the launch of the new website at the business meeting on Sunday and let everyone know that the website is ready for preview. The website has to be previewed by all the committee chairs and officers of Area 15 and if everything looks good the Area 15 Web Committee will submit a motion for the next Area Quarterly to go "live" with the site.

We had 2,081 sessions with 1,219 of them first time visitors. The site received 4,259 page views with the average person on the site viewing 2.05 pages per sessions. Average time on the site is 2 minutes and 17 seconds. 51.18% of all visitors were new.

We added a few meetings to the website and app last month and they are reflecting all the current meetings available. If you want to add or change anything about the schedules we have listed please email the Web Committee. Contact info is on the website.
